COVID-19 Guidelines and Procedures

Adapted from the State of Georgia's Day Camp Procedures Issued on March 12th, 2020

All campers, camp staff, and theatre employees are required to have a signed COVID-19 Waiver on file before participating in camp activities. Those who elect not to sign this waiver will not be permitted to attend camp sessions, and a refund of camp tuition will be provided.

Campers, camp staff, and theatre employees cannot enter the Grand Theatre or other designated camp location if they have been diagnosed with COVID-19, have exhibited symptoms of COVID-19, or have had contact with a person that has or is suspected to have COVID-19 within the past fourteen (14) days. Signage will be placed at each entrance to remind campers of this requirement.

Campers, camp staff, and theatre employees will be required to adhere to enhanced sanitation procedures, Social Distancing requirements, and other instructions and limitations as listed below and on signage throughout the Grand Theatre:

- Upon arrival for a camp session, campers and camp staff must remain outside of the building until instructed otherwise.
- Parents and guardians must remain outside of the theatre for check-in and check-out.
- We will be using contactless forms for check-in and check out.
- Parents may walk their child to the designated area outside of the theatre for check in, which will consist of a temperature scan and verification that the child has not had or come into contact with someone exhibiting the COVID-19 symptoms of a temperature over 100.4 degrees Fahrenheit, cough, shortness of breath, difficulty breathing, other respiratory symptoms, or at least two of the following symptoms: chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- Campers and camp staff will be prevented from entering the theatre if they have a temperature over 100.4 degrees Fahrenheit or have had or come into contact with someone exhibiting the previously-listed symptoms.
- Anyone exhibiting a temperature over 100.4 degrees Fahrenheit or any of the previously-listed symptoms during the camp day will be immediately separated from the group. If a camper, a call will be made to a parent or guardian and we will require that camper to be picked up as quickly as possible. If a camp staff member, the individual will be sent home.
- Any camper or camp staff member who has stayed home sick or who has been sent home will not be permitted to attend camp again until they've had a negative COVID-19 test or have been fever-free without the use of medication for at least seventy-two (72) hours, so long as they do not have additional symptoms. If they do show additional symptoms linked to COVID-19, they must stay away until at least ten (10) days have passed since their symptoms first appeared.

- If necessary, we will implement a staggered drop-off and pick-up procedure. We'll provide information on this in the event that we feel it will benefit the safety of our campers and staff.
- No one but campers, camp staff, and theatre employees will be permitted in the theatre. We will not be providing tours, and our theatre doors will remain closed and locked during the camp day.
- Camp staff will be trained on identifying symptoms of illness in campers and on the proper processes of removing a potentially ill camper, as well as what to do in the aftermath of such an event.
- We will be limiting groups to twenty individuals or less, including camp staff and theatre employees, where everyone gathered cannot maintain at least six feet of distance between themselves and others.
- We will designate a space for each camper to keep his/her personal belongings during the duration of camp, and this space will be cleaned daily.
- Camp equipment and facilities will be routinely sanitized.
- Additional theatre staff will be deployed to help enforce sanitation and social distancing procedures amongst campers.
- Hand sanitizer and other cleaning supplies will be provided to campers to use throughout the day, and campers and camp staff will be required to wash and sanitize their hands regularly.
- Campers and camp staff will not be permitted to share lunch or snack items.
- Camp staff and theatre employees will be required to wear masks at all times and gloves when coming in direct contact with a camper or item belonging to a camper. Campers will also have access to gloves. Masks will also be provided as necessary, and campers and camp staff are encouraged to bring their own masks if they so choose.
- Theatre restrooms used during camp sessions will be sanitized at least twice a day.
